1. Adoption of the “Red Flag” Ordinance.
(The Federal Trade Commission (FTC) has implemented rules and regulations for utility providers to enact programs to prevent identity theft.)
2. Authorization to execute the City of McDonough Sanitation Contract with Republic Services, Inc.
3. Approval of the request for qualifications for the Architect’s Design Services and General Contractor for the Police and Court Facility.
4. Authorization to execute Hotel Administration Service Agreement with GMA. The enhanced version (tracking/collection/audit) cost is \$700.00 per hotel and the City presently has 14 hotels. Therefore cost for the service agreement will be \$ 9,800.00.
5. Authorization for an Addendum to be added, and executed by the Mayor, to the Intergovernmental Agreement between Henry County and the City of McDonough. (The Agreement was approval for the County to conduct the municipal elections for the City on an on-going basis until either party terminates the contract.) The Addendum authorizes approval that the City of McDonough voting precincts have been changed and now for McDonough voters there will be one designated voting place at the Henry County Board of Elections and Registration Office, located at 345 Phillips Drive, McDonough, GA.
